This commitment has established the studio's public sector focus and international reputation for award-winning architecture, as well as Paul's leadership in housing policy, public investment and socially responsible practice.

Designing inclusive, affordable and well-integrated cities is one of the defining challenges of our time. Paul leads the practice's design excellence and housing expertise across all scales, from individual homes and public buildings to complex masterplans, frameworks and urban strategies. Bringing together design, policy, delivery knowledge and a collaborative ethos, he ensures homes and neighbourhoods are thoughtfully crafted and well detailed, creating places that bring pride, delight and opportunity to the people who live there.

Paul works closely with resident and community groups alongside ambitious public-sector clients in the UK and internationally. Throughout his career he has championed grassroots involvement in the shaping of cities and established the practice's in-house engagement team and social value programme to ensure communities are active participants in the design of their own environments.

Alongside his architectural work, Paul supports organisations committed to well designed housing and equal opportunity.
